# RED CARD GAMBLING SUPPORT PROJECT: SAFEGUARDING AND CHILD PROTECTION POLICY

This policy applies to all staff, including senior managers and the board of trustees, paid staff, volunteers and sessional workers, agency staff, students or anyone working on behalf of RED CARD GAMBLING SUPPORT PROJECT.

Safeguarding is about embedding practices throughout the organisation to ensure the protection of vulnerable adults and children wherever possible. In contrast, Child and **Adult Protection** is about responding to circumstances that arise.

#### Definition of a child

A child is under the age of 18 (as defined in the United Nations convention on the Rights of a Child).

Abuse is a selfish act of oppression and injustice, exploitation and manipulation of power by those in a position of authority. This can be caused by those inflicting harm or those who fail to act to prevent harm. Abuse is not restricted to any socio-economic group, gender or culture.

# It can take a number of forms, including the following:

- Physical abuse
- Sexual abuse
- Emotional abuse
- Bullying
- Neglect
- Financial (or material) abuse
- Hate Crime

## The purpose of this policy:

To protect children and young people who receive RED CARD GAMBLING SUPPORT **PROJECT** services.

- This includes the children of adults who use our services.
- To provide staff and volunteers with the overarching principles that guide our approach to safeguarding and child protection and young adults.

 Believes that a child – including unborn children - or young persons should never experience abuse of any kind. We have a responsibility to promote the welfare of all children and young people and to keep them safe. We are committed to practise in a way that protects them

#### Legal framework

## **RED CARD GAMBLING SUPPORT PROJECT** recognises that:

- The welfare of the child is paramount, as enshrined in the Children Act 1989
- All children, regardless of age, disability, gender, racial heritage, religious belief, sexual orientation, or identity, have a right to equal protection from all types of harm or abuse
- Some children are additionally vulnerable because of the impact of previous experiences, their level of dependency, communication needs or other issues
- Working in partnership with children, young people, their parents, carers, and other agencies is essential in promoting young people's welfare.

RED CARD GAMBLING SUPPORT PROJECT will come into contact with children through the following activities:

- Educational events, workshops and talks (in-person and online)
- Telephone, website, and e-mail inquiries

#### We will seek to keep children and young people safe by:

- Valuing them, listening to and respecting them
- Appointing a Designated Safeguarding Officer (DSO) for children and young people, a deputy and a lead board member for safeguarding
- Adopting child protection and safeguarding practices through procedures and a code of conduct for staff and volunteers
- Developing and implementing an effective safety policy and related procedures
- Providing effective management for staff and volunteers through supervision, support, training and quality assurance measures
- Recruiting staff and volunteers safely, ensuring all necessary checks are made
- Recording and storing information professionally and securely in accordance to GDPR regulations, and sharing information about safeguarding and good

practice with children, their families, staff and volunteers via leaflets, posters, one-to-one discussions

- Using our safeguarding procedures to share concerns and relevant information with agencies who need to know, and involving children, young people, parents, families and carers appropriately.
- Using our procedures to manage any allegations against staff and volunteers appropriately
- Creating and maintaining an anti-bullying environment and ensuring that we have a policy and procedure to help us deal effectively with any bullying that does arise
- Ensuring that we have effective complaints and whistle-blowing measures in
- Ensuring that we provide a safe physical environment for our children, young people, staff, and volunteers, by applying health and safety measures in accordance with the law and regulatory guidance
