### Project spotlight



Red Card Gambling CIC are dedicated to reducing gambling related harms for all in the UK, and use a lived-experience model to engage with communities. The team run a number of projects, most notably their project aimed at the semi-professional football sector, as well as delivering workshops to schools and youth clubs as part of their young people's project, and the delivery of their CPD accredited online and in-person training courses.

Tony, a former professional footballer and now the CEO and Founder of Red Card, said "we very excited to be part of a new project which aims to support people from Caribbean/African/South Asian communities who are affected by gambling harms. Our aim is to educate, raise awareness and remove the stigma that is attached to gambling within these communities, encouraging more open and honest conversation in a safe space. We encourage all organisations to engage with people on the ground, and we pride ourselves in being visible out in the community, ensuring we create a bond, and positive relationships with the communities we serve".

## Funding programme updates

#### **Improving Outcomes Fund**

Our Education and Training Team held 2 drop in sessions for top tips for engagement on gambling harm. We hope that those who attended found it useful, we loved hearing all your ideas on what successful engagement looks like in your communities and projects.

#### Community Resilience Fund

We are still in the process of finalising the peer review for the end of year evaluation report. In the coming weeks, Ipsos will be reaching out to the 4 organisations for the case study work in the year ahead so look out for that email.

#### **Aftercare**

This month, our evaluation and learning partner, lpsos, started one-to-one conversations with projects to refine their monitoring and evaluation approaches. We hope we can offer similar support to the rest of the portfolio so keep an eye out for more information.

### Research

Research indicates that individuals who accessed Gambling Help Online are significantly more likely to adopt positive self-help strategies. From setting limits to seeking support, these proactive steps can lead to lasting change. The full publication, carried out by Alma Economics, commissioned by GambleAware, can be found here





A new <u>report</u> titled 'Gambling Harms and Coping with Marginalisation and Inequality', authored by <u>National Centre for Social Research</u> and funded by GambleAware was published this week. The report shows how individuals from marginalised communities use gambling to cope with challenges like social exclusion, mental health issues, and poverty. Stigma around gambling harms, intersecting with issues like homelessness and mental health, makes seeking support difficult.

The report was also highlighted in the <u>Big Issue</u>.



The Gambling Commission launched a new gambling survey which is set to become one of the largest in the world and establish a new baseline for understanding gambling behaviour in Britain. The survey features responses from 9,804 individuals and found that harm from problem gambling in Great Britain may be eight times higher than thought previously.
